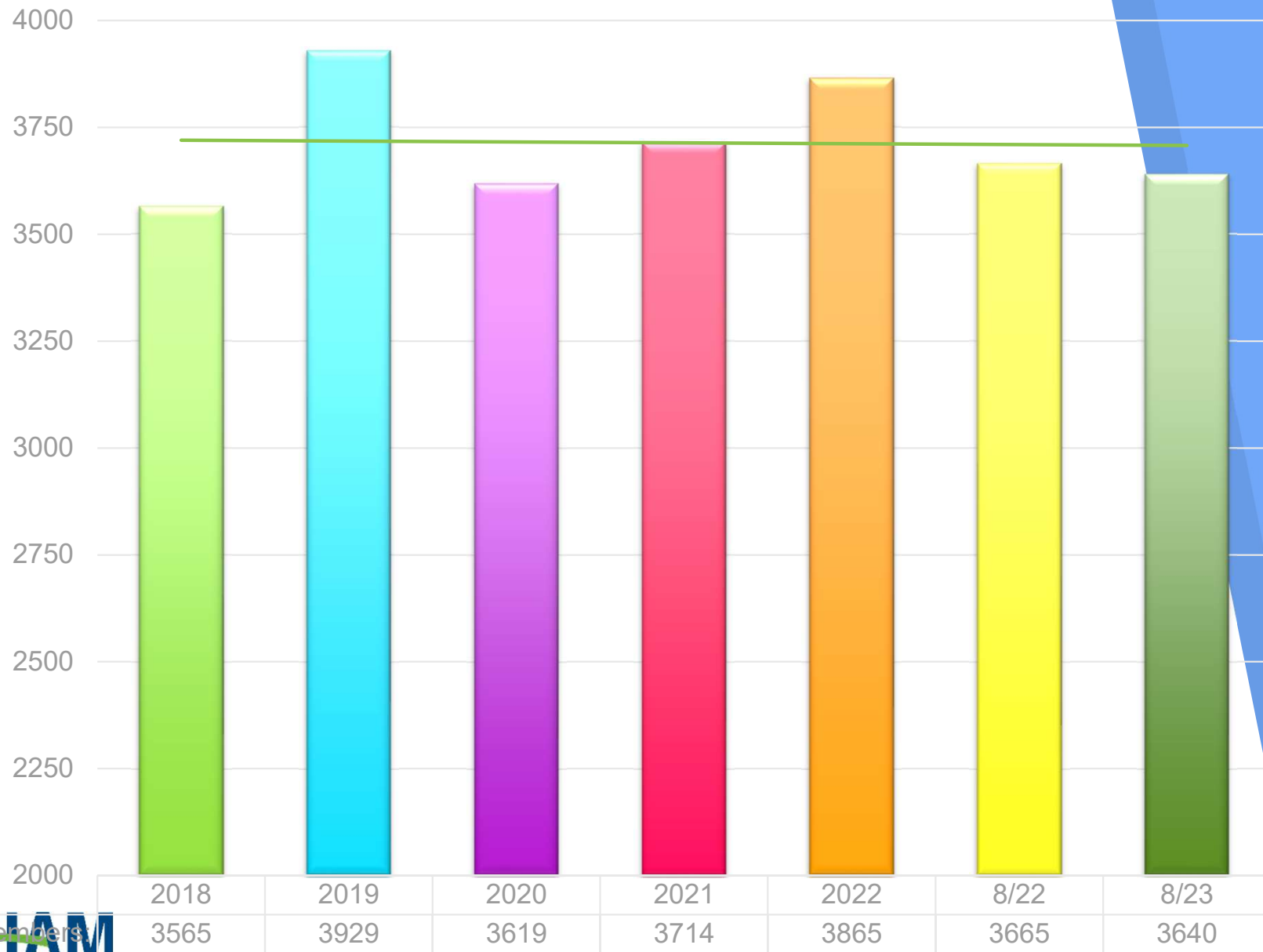

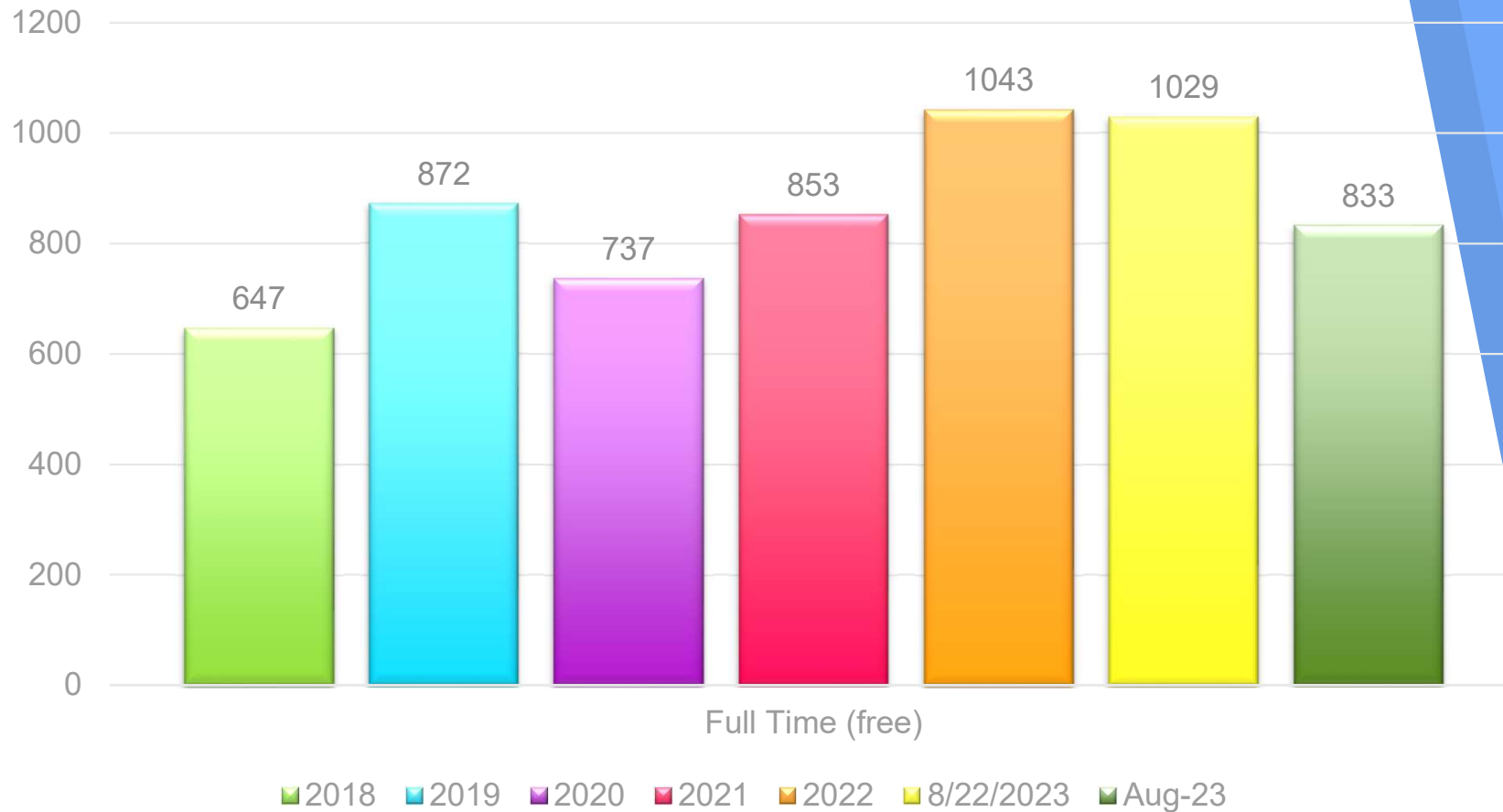

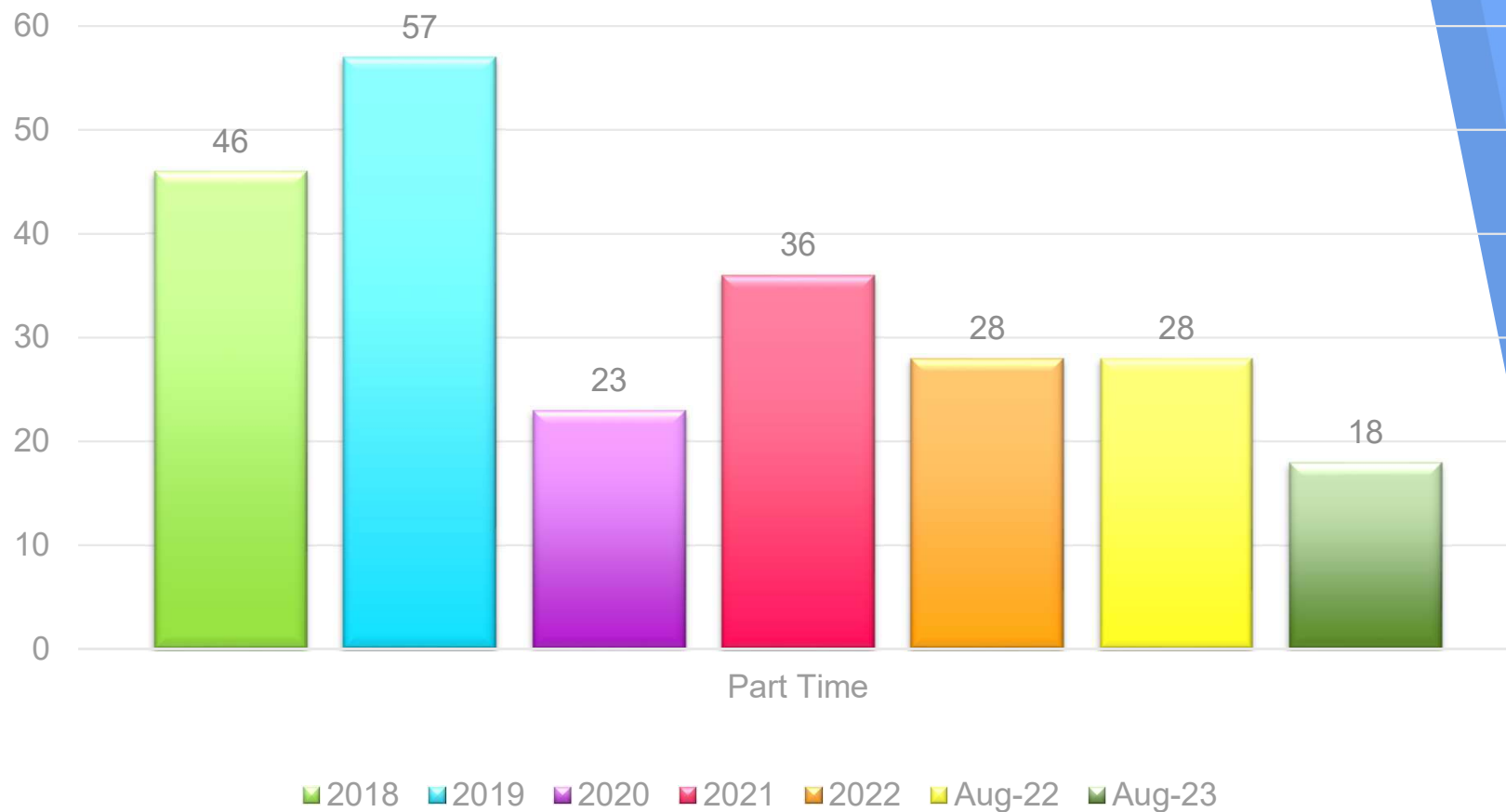
Membership Totals (as of 8/31/23)

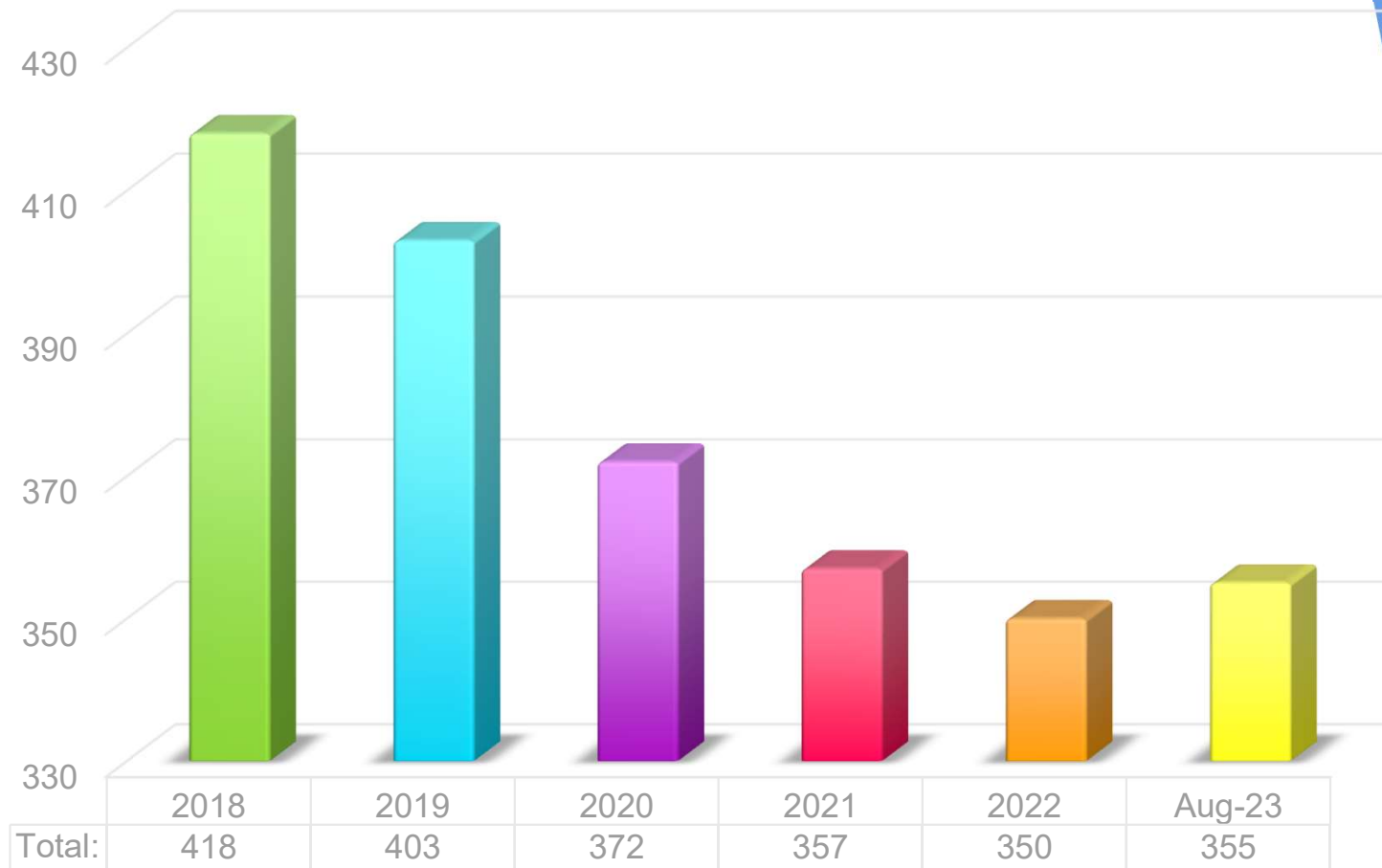

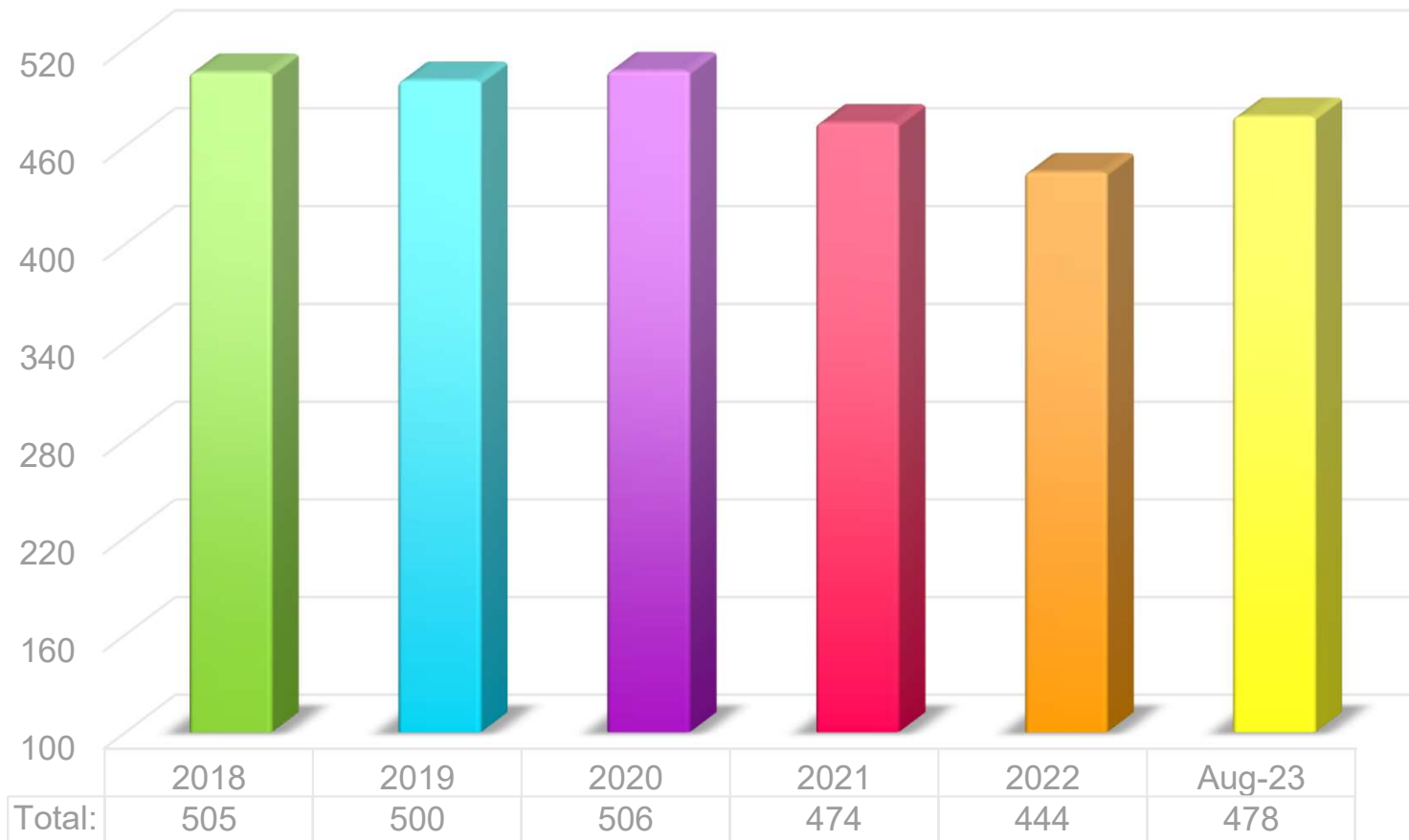
2023 Certification Exams

- ▶ Total Exams Passed – 265

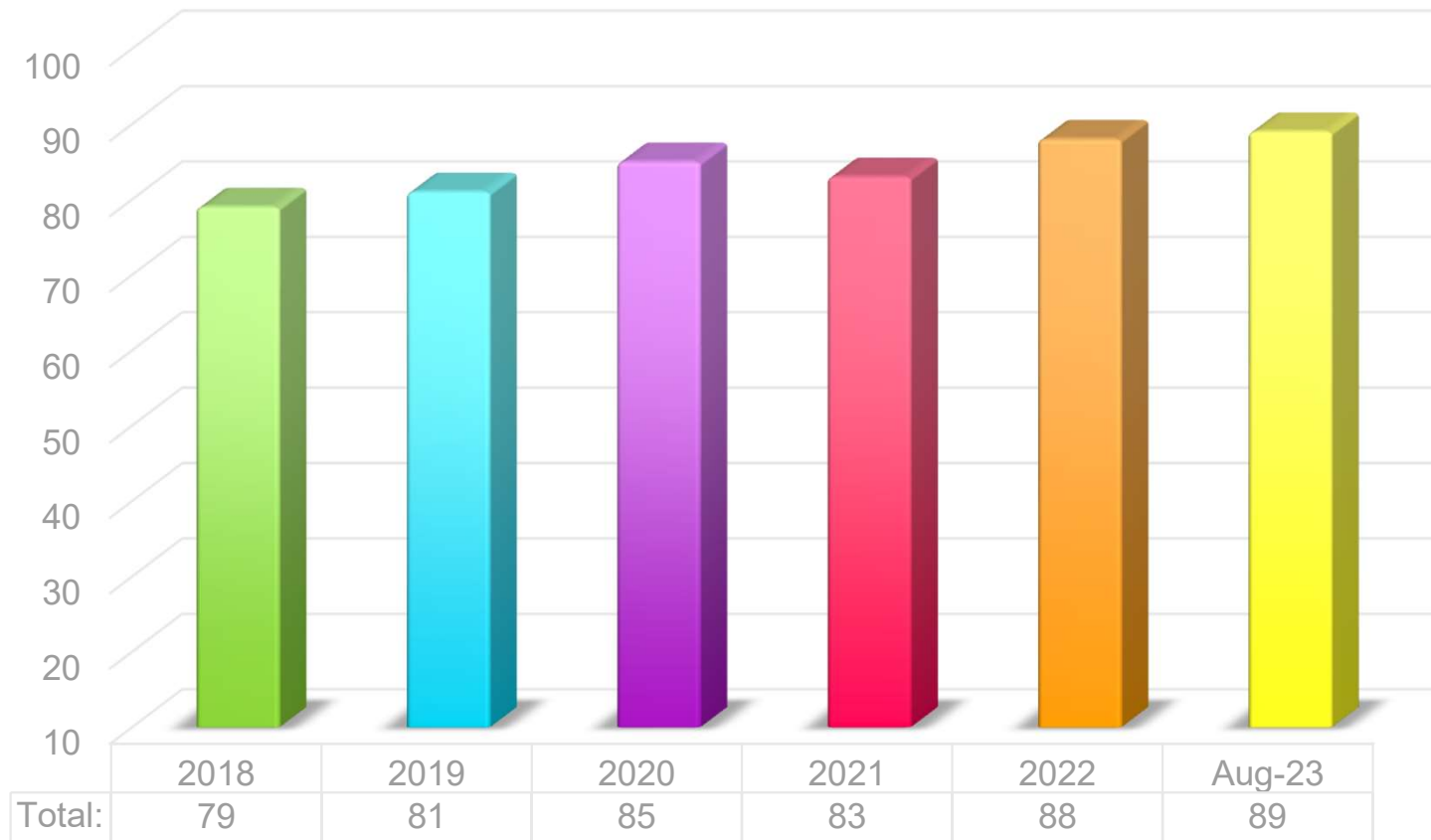

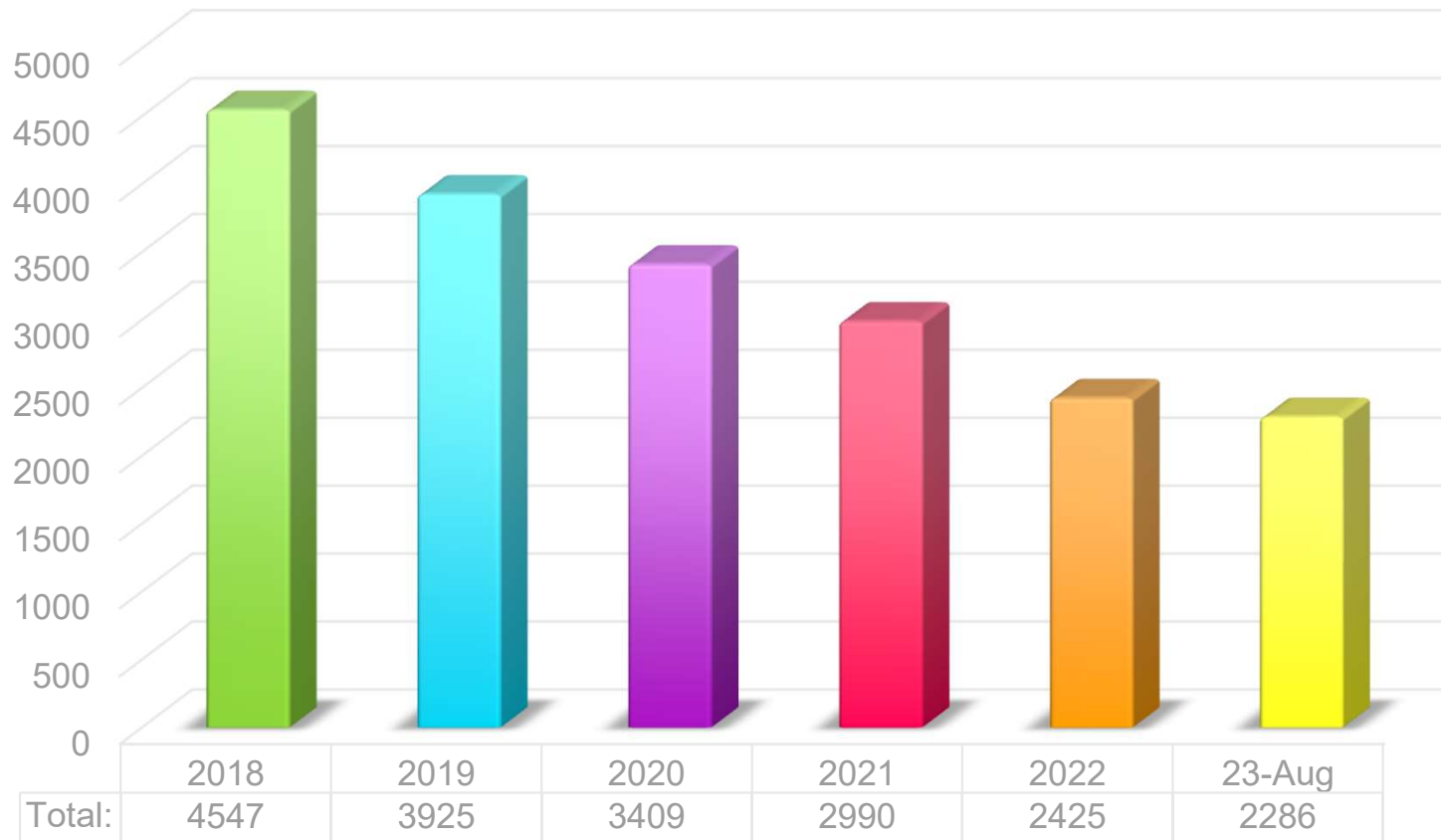
Total CRCP



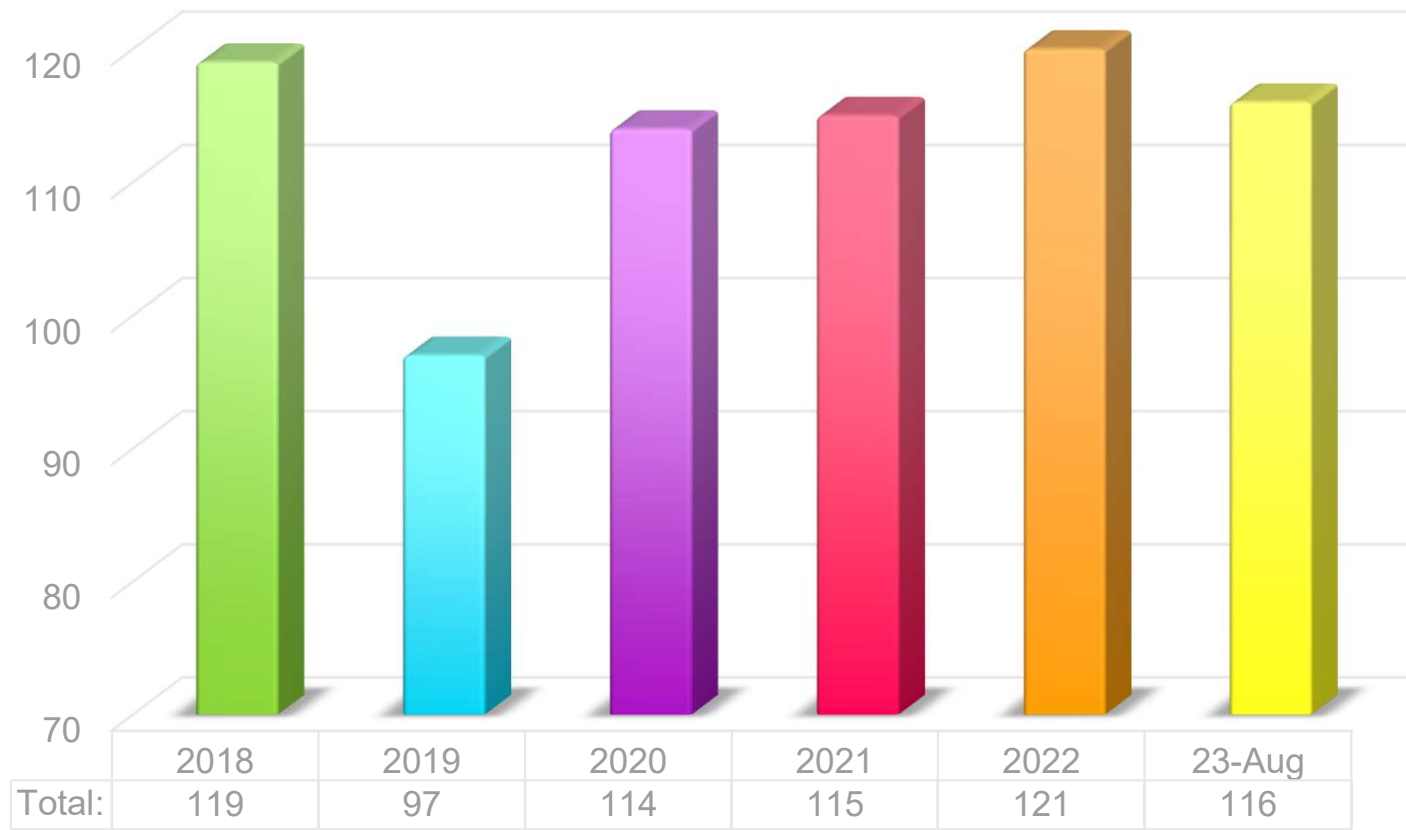
